**TERMS & CONDITIONS . . .**

Please read these terms carefully before signing this agreement. DJ = Daisy Janie. R/M = Reseller/Manufacturer.

- 1. Nature of Fabric.** DJ's wholesale organic fabric collections are produced with cotton that has been grown, harvested, processed and woven according to the Global Organic Textile Standard (GOTS, www.global-standard.org). Low-impact dyes and pigments used in printing, and finishing methods used for softness and luster, are also in accordance with the GOTS. As such, the fiber, fabric and printing are all GOTS-Certified. In addition, the fabric is produced in a Fair Trade Certified facility. Minor imperfections and an off-white ground cloth may occur due to the eco-friendly means of producing DJ organic fabrics.
- 2. Availability and Color.** DJ fabrics are available to R/M on a first-come, first-served basis. Quantities are limited, production lead times are long, and DJ does not guarantee all styles will be available at all times. Every effort will be made to accommodate R/M's preferences. Color shifts may occur when styles are produced in different runs/dye lots. To maintain color consistency across/within styles, purchasing bolts from the same run when available is strongly encouraged.
- 3. Shipping.** All US orders are shipped via UPS Ground using R/M's account info provided. If R/M does not have a UPS account, DJ will ship using our UPS account, in which case a handling surcharge will be incurred. International orders are shipped either UPS or USPS, depending which one represents the best value. Taxes, duties, tariffs and other such assessments are the sole responsibility of the R/M.
- 4. Payment.** DJ requires payment-in-full prior to shipment. Visa/MC is strongly preferred. DJ will accept money orders or certified checks. Payments will be processed at time of order fulfillment. Credit terms are not available.
- 5. Damages/Claims.** DJ warrants all fabrics delivered to R/M to be first quality, barring minor imperfections or off-white ground cloth as mentioned in Nature of Fabric above. R/M should perform a quality inspection of shipment upon arrival. R/M has 10 days from date of receipt to contact DJ with a written claim, citing damaged, defective or incomplete orders. Incomplete orders will be fulfilled in accordance with R/M's Order. Exchanges or credit will be given for damaged or defective goods but will not be granted if fabric has been cut and/or otherwise processed or distributed. DJ will replace damaged or defective goods at its discretion and shall only be obligated to replace only such quantity or credit value of the fabric proven to be damaged or defective. If package appears damaged upon arrival, please contact DJ immediately for further instruction.
- 6. Limitation of Liability.** DJ is not liable or responsible for suitability of fabric for a particular application, merchantability, or any injury, loss or damage, direct or consequential, arising out of the use or inability to use the fabric. R/M and its customers assume all risk, responsibility and liability for use of DJ fabrics. Products manufactured using DJ fabrics are the sole responsibility of the R/M, and DJ cannot be held liable for any legal action related to product or R/M's actions or operations.
- 7. Refunds/Exchanges/Cancellations.** Fabric is nonreturnable, and all sales are final unless fabric is damaged or defective. Additions and/or exchanges may be made prior to shipment. Exchanges desired after delivery are not permitted. Cancellations must be received in writing at least 10 days prior to the collection's initial ship date (TBD).
- 8. Exclusivity.** DJ fabrics are nonexclusive to any R/M, product or product category. Further, using and/or reselling DJ fabrics does not constitute or imply a partnership, joint venture or agency relationship between DJ and R/M.
- 9. Fair Profit.** Advertising or listing retail prices below DJ's suggested retail price (MSRP) within 30 days of a collection's release date (TBD) is strongly discouraged. R/Ms who engage in this activity risk termination of their wholesale account with DJ. Volume discounts are exempt.
- 10. Other.** DJ fabrics are not intended for children's sleepwear as they do not meet the flammability standards set forth by the US Consumer Product Safety Commission. DJ reserves the right to refuse orders or limit sales at its sole discretion and does not permit wholesale accounts to fabric co-ops.
